Can you describe and/or demonstrate the specific impact that TFN funding has had against your initial objectives?	Thanks to the support received from The Funding Network we were able to help over 100 people from January to March (pre-lockdown) in face to face legal advice surgeries and in completing the government Compensation Scheme application forms.
	We used some of the funds to hold a public town hall meeting at Lambeth Town Hall attended by c.200 people to spread awareness of the Compensation Scheme. The event was covered by local media and included a panel of speakers including Martin Ford QC, the designer of the Scheme itself.
	Following the first Covid lockdown of March 2020 we had to pause the in person surgeries, but we had secured in the same month further funding to continue the surgeries.
	We have also supported (by knowledge sharing) similar advice surgeries around the country, especially by the members of the self-organising Windrush National Organisation.
	As a result of our efforts and work to provide the advice and relief to the people affected we were invited to share our expertise with the Home Office, as members of the Cross-Government Windrush Working Group. Our work in this group focuses on the implementation of the Government's Lessons Learned Review into the Widnrush Scandal. Outcomes so far have included an increase in payments, and a shortening of the time taken for payments to be disbursed to claimants.

Can you tell us any personal stories to highlight the value of the project?	One of the people who attended the January event was a man who had been rough sleeping. We found him accommodation for the night and our legal partners in this endeavour, McKenzie Beute and Pope, took on his case to arrange for his immigration status to be resolved.
