	hours per week. Our most recent paralegal vacancy was publicised
	via our Young ELF university network, and we were inundated with around 100 applications.
	We are now working with 15 universities and there is a particular
	interest in policy clinics. These provide opportunities for longer term
	empirical research. We ran two projects last year (on Climate
	Emergency Declarations (CEDs) and Neighbourhood Planning) and
	have three this year. The CED project involved 8 universities,
	researching different regions of the UK and providing ELF with regional reports. ELF then published a national overview report
	immediately prior to COP26 . Officer time involved in co-ordinating
	the project and producing the report was more than anticipated.
	However, research on such a scale would not have been possible
	without the assistance of the university network
	Covid-19 restrictions limited our ability to provide public outreach
	events. However, we were able to deliver online webinars aimed at
	the Young ELF audience. Following discussions with a social justice
	charity working with young people we planned to deliver a
	workshop as part of their training programme but unfortunately this was cancelled. We had some helpful discussions with a university
	regarding Streetlaw presentations which demonstrated that this will
	require a lot of preparation and so further work is required to
	develop this aspect of the Young ELF programme. However, we have
	been able to add recordings of some ELF webinars to the resources
	page on our website.
	We were able to progress a three-year strategy with accompanying
	annual operational plan. We have continued to seek further grant
	funding support and had some positive funding discussions with
	funders regarding plans to further develop our paralegal capacity to



	be able to offer full time roles although the primary funding application for this was unsuccessful.
What portion of the project did TFN fund?	30% (of core work)
How many direct beneficiaries did the TFN funded project reach?	Five - two officers, two paralegals, one comms assistant
How many indirect beneficiaries did the TFN funded project reach?	ELF receives over 300 enquiries per year and behind each enquiry there is a community. We estimate that ELF reaches indirectly tens of thousands of individuals every year.
Were you able to leverage further funding as a result of TFN support?	Yes
If yes, how much were you able to raise?	We were delighted that the Tudor Trust who had provided us with unrestricted funding over three years have extended their funding for a further three years on the strength of the work we are doing.

The role has not yet been replaced as other funding applications have been unsuccessful, requiring the current executive team to hold additional responsibilities.

Can you tell us any personal stories	ELF has so many stories but to pick out a few.
highlight the value of the project?	1. Better Streets for Kensington and Chelsea. ELF has been working with the group on their challenge to the London Borough of Kensington and Chelsea's decision to remove a segregated cycle lane down Kensington High Street. After extensive consultation and the use of over £300k in public funds, the cycle lane was taken out after only 6 weeks. The group have sought to challenge two decisions. The first to remove the lane was pre-determined. When ELF pointed this
	out a new decision was taken in March 2021 to research the position. We are challenging this latest decision and have been granted permission by the court to proceed, lack of consultation being one of the grounds. See here .
	2. ELF has been working with the Woodcock Hill Village Green Committee for over a year and is now heavily involved with a Public Inquiry on their behalf. ELF is instructing Counsel for the community. The Public Inquiry relates to an application by Taylor Wimpy (TW) to de-register a large portion of the Woodcock Hill Village Green. It was registered as a Village Green in 2008, the original application having been made in 2004. It is an idiosyncratic area of the law and a deregistration application unusual. In the long term TW want to build houses on this site. TW have to demonstrate that the replacement land that they are proposing instead of Woodcock Hill VG is at least as good if not better. The community have loved, treasured and maintained this wild Local Wildlife Site for years and now face the real prospect of losing it. It is a typical ELF, David and Goliath case. We say the replacement land is in no way comparable to what will be lost to the community. We have also pioneered working with a team of law students at City University, one of our university clinic members, on this matter. Working with the barrister, they were set the task of scrutinising the applicant's expert's evidence and producing a document. It was a great experience for the students to
	work on a case such as this under the supervision of a barrister. There is more about the case on ELF's website here . 3. Assisting a local group to obtain environmental information (ecology reports) which had not been made publicly available and when we made a request under the Environmental Information Regulations, it was denied them. We have been working with Sussex

University, another of our university clinic members. We were
