Can you describe and/or demonstrate the specific impact that TFN funding has had against your initial objectives?	Our programme equipped Trainees with the skills, confidence and network to gain secure long-term employment, taking them out of unemployment and into financial stability. Over the six-month pilot, we worked with six young adult offenders. Of the six, four completed a 12-week work experience programme and the other two received culinary and customer service training before moving onto further training with another organisation. Outside of our direct beneficiaries, we worked with our restaurant employer partners to share our knowledge on training and employing young, unemployed people and at-risk/ex-offenders. 6 beneficiaries 4/6 Level 2 Food Hygiene and Safety qualifications 6/6 increased confidence securing employment in the food industry 6/6 completing one-week Training Bootcamp 4/6 completing 12-week Work Experience Programme 4/6 securing employment with our partners - with the other two

Unfortunately I am not in a position to carry on that mission.
	I'm currently working with our board to explore opportunities for one or more of our charity partners to receive our remaining assets and use them to carry on the legacy of the project. Though we know that this is the end of the journey for Kitchenette Karts, we're hopeful that it's the beginning of a new journey for another social enterprise or charity that wants to take on our mission.
